## Responsibility

We see our home as a privilege. It has influenced us, it is the basis for our identity, strength and inspiration. Our business policy is based on generally applicable ethical values and principles, in particular honesty, integrity and respect for human dignity. We educate and train and ensure that the traditional jewellery crafts and trades of our home region are preserved.

As a family company in it's fourth generation, we see ourselves as having a special responsibility to preserve this inheritance of values, traditions and expertise, that we have entrusted with and to develop them further for future generations. As early as 1720, the family of Hans D. Krieger has been closely associated with the gemstone industry in Idar-Oberstein in a colorful sequence of different professions: agate grinders (in the then still water-powered grinding mills), goldsmiths, engravers, pearl drills and pearl cutters, gemstone cutters and diamond cutters. Hans Johann Krieger founded the diamond grinding company in 1935, which Hans-Dieter Krieger took over after the sudden death of his father in 1964. The fascination for stones inspired him to create and manufacture pieces of jewelry. Today the company is one of the most important manufacturers of exclusive diamond and colored stone jewelry.

The Responsible Jewelry Council (RJC) is a non-profit organization that was founded in 2005 with the aim of strengthening, in a transparent and comprehensible way, responsible, ethical, human rights, social and environmentally friendly working methods throughout the supply chain for jewelry made from diamonds, gemstones, gold and platinum metals. It covers everything from mining to retail. This is intended to strengthen the confidence of all stakeholders in jewelry made from diamonds, gemstones, gold and platinum metals. Each member undertakes to follow the RJC's code of conduct. All certified members of the RJC are assessed by approved external auditors to demonstrate that they comply with the RJC's Code of Conduct. The RJC is a full member of the ISEAL Alliance - the international association for sustainability standards.
